Student Behavior Expectations:

- 1. Students will conduct themselves in a safe and respectful manner at all times. They will follow **any** adult's direction or request immediately without argument or question.
- 2. Students will not participate in any form of violent behavior.
- 3. Students will not participate in any hazing, bullying, intimidation, threats of violence, harassment or any form of inappropriate controlling behavior, either verbal or physical.
- 4. Students will not damage or deface any property. Families will be held responsible for any monetary reimbursements due to property owners if this occurs.
- 5. Students will not bring objects that are deemed dangerous or disruptive (pocket knives, fireworks, etc.) nor possess or use any illegal objects.
- 6. Students will not possess nor use/consume alcohol, drugs, tobacco, or nicotine products. Failure to abide by this will result in immediate removal from event, parent/guardian contact, and the same disciplinary consequences as if the incident occurred on school grounds.
- 7. Students will not use verbally inappropriate or abusive language nor physically inappropriate or abusive actions at any time during the event, including on the bus.
- 8. If reinstated, students will abide by all COVID-based safety regulations, including mask wearing when not seated and maintaining social distance from other students. A specific list of COVID guidelines will be provided to all students, if necessary.

These expectations are not meant to be all-inclusive, and any action deemed inappropriate by a chaperone that is reported to a chaperone may be subject to the disciplinary actions outlined below. Please note that we, any chaperones, and/or anyone providing support of any kind (staff at location, bus driver, etc.) is able to assign and enforce these discipline measures.

Disciplinary Procedures:

Depending on the severity of the offense, the following actions may be taken:

- 1. The student will be warned against future infractions.
- 2. The student may be removed from the situation and asked to stay with an approved chaperone. A parent/guardian will be notified of the situation.
- 3. A parent/guardian may be notified and asked to come and remove a student from the venue.
- 4. If necessary, law enforcement may be contacted.
- 5. In the interest of safety, we reserve the right to withhold a student from any activity during the event.
- 6. If damages are involved, the student will be responsible for the repair. A parent/guardian is ultimately responsible for any damages incurred by his or her student.

Transportation Procedure:

The only transportation to and from Prom will be provided by the school. Any student wishing to leave the event early must be signed out by his/her parent/guardian at the event's location. Under no circumstance may a student leave any portion of the event with another student nor another student's parent/guardian.
